

**ORDINANCE NO. 2015-06**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COPPERAS COVE, TEXAS REPEALING ORDINANCE NO. 2013-39 WHICH LIMITED A SEGMENT OF MIRANDA AVENUE TO ONE WAY TRAFFIC FROM 7 A.M. TO 4 P.M. UNTIL CONSTRUCTION COMPLETION; REPEALING ALL ORDINANCES IN CONFLICT WITH THIS AMENDMENT; PROVIDING A SAVINGS CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS,** the Copperas Cove Independent School District requested that Miranda Avenue, from Henry Street to Patricia Street be designated for one-way traffic during the hours of 7 a.m. to 4 p.m. beginning August 22, 2013 and

**WHEREAS,** the Copperas Cove Independent School District has requested that Miranda Avenue, from Henry Street to Patricia Street remain open only to one-way traffic during the hours of 7 a.m. to 4 p.m., until such time that construction work in the area around Martin Walker School is completed; and

**WHEREAS,** the Copperas Cove City Council deemed it in the best interest of the health, welfare, morals and safety of the community to satisfy the request; and

**WHEREAS,** the Copperas Cove City Council shall repeal this ordinance upon the completion of construction work in the area around Martin Walker School and

**WHEREAS,** with the construction completion and opening of the SE Bypass/FM 2657 Project the ordinance is no longer necessary and should be repealed.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COPPERAS COVE, TEXAS:**

**SECTION 1.**

That the City Council hereby repeals Ordinance No. 2013-39, limiting a segment of Miranda Avenue to one-way traffic from 7:00 a.m. to 4:00 p.m. with construction completion; and, henceforth Ordinance No. 2013-39 shall have no further force and effect.

**SECTION 2.**

That all ordinances for which provision has heretofore been made are hereby expressly repealed if in conflict with the provisions of this ordinance


**SECTION 3.**

That should any section, clause, or provision of this ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of this ordinance or any other ordinance of the City as a whole or any part thereof, other ordinance of the City as a whole or any part thereof, other than the part so declared to be invalid.

**SECTION 4.**

That this ordinance shall go into effect immediately upon passage of the ordinance.
