

**ORDINANCE NO. 2015-52**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COPPERAS COVE, TEXAS AMENDING THE FEE SCHEDULE FOR THE CITY OF COPPERAS COVE; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING A SAVINGS CLAUSE; AND DECLARING AN EFFECTIVE DATE.**

**WHEREAS,** The City of Copperas Cove adopted an updated "Fee Schedule" on September 1, 2015 for Fiscal Year 2015-2016; and

**WHEREAS,** Various fees charged by the City of Copperas Cove were reviewed since adoption and fee additions are required for new policies and programs; and

**WHEREAS,** City staff recommends changes to the current fee schedule in order to provide cost recovery and flexibility.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COPPERAS COVE, TEXAS:**

**SECTION 1.**

That the "Fee Schedule" attached to this ordinance as "Exhibit 1" and incorporated herein by reference is hereby adopted as presented and effective December 15, 2015.

**SECTION 2.**

That the City Council grants authority to the City Manager to waive and/or adjust fees as appropriate, consistent and fair on a case by case basis.

**SECTION 3.**

That all ordinances for which provision has heretofore been made are hereby expressly repealed if in conflict with the provisions of this ordinance.

**SECTION 4.**

That should any section, clause, or provision of this ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of this ordinance or any other ordinance of the City as a whole or any part thereof, other than the part so declared to be invalid.


**SECTION 5.**
