## *2006 ANNUAL REPORT*

Dear Mayor, City Council Members, City Manager, and Citizens of Copperas Cove:

On behalf of the men and women of the Copperas Cove Fire Department, I respectfully submit the Annual Report of the Copperas Cove Fire Department for your review.

The Copperas Cove Fire Department is responsible for fire and EMS response, fire prevention and inspections, fire investigations, emergency management, and code enforcement services to our citizens. We provide this service from three fire stations with forty-eight full-time personnel and an annual operating budget of \$2,976,673.

During the past year, the Copperas Cove Fire Department responded to 3,148 requests for ambulance and 1,106 requests for fire related incidents. Additionally, we responded a fire unit to assist an ambulance on 1,177 alarms, bringing the total number of emergency responses to 5,431 for this year. For the first time in many years, this number represents no increase in total service over the previous year.

The Copperas Cove Fire Department is the primary provider of fire and EMS services to approximately 12,000 residents who live within 90 square miles of southern Coryell County. We provide these services under a contractual agreement; however, payment received from Coryell County is for fire suppression services only. The amount paid to the department is based on the number of square miles covered and the number of emergency responses into the service area. In 2006, the department responded to 490 calls for service within Coryell County and received a total of \$36,264 or an average of \$74 per emergency response. This is largely due to the fact that the department receives payment from the county for FIRE responses only and not for any emergency medical services.

The fire department also provides mutual aid assistance for both fire and EMS calls into Burnet, Bell and Lampasas Counties, of which, only Bell County provides payment for these responses. The total number of emergency responses into all counties for 2006 was 704, or approximately 12% of our total call volume for the year.

The past year was a very busy and demanding year for our department. Some of the notable accomplishments for the year included:

- Received a grant from Wal-Mart Foundation for \$1,250 for the “safe neighborhood” program.
- Purchased and place one (1) new ambulance into service.
- Conducted 677 fire inspections, correcting 393 identified fire hazards.
- Received 1,183 code enforcement complaints from citizens and city employees.
- Conducted 53 separate food handler classes to a total of 1,069 students.

- Contacted 6,831 adults and children through fire prevention tours and demonstrations.
- Responded to 150 vehicle accidents on HWY 190, which represents over 50% of the total vehicle accidents for the year.
- Replaced old rescue truck with an SUV to also serve as a second command vehicle, when needed.
- Hired one additional Code Enforcement Officer and a new Emergency Management Coordinator.
- Provided 1,156 free immunizations through the "Shots through the Firehouse" program, bringing to total free immunizations to over 6,000 since its inception.

I want to thank each of you for the continued support that you have provided us throughout the year.

# Chapter 1

## Department Organization

### Organization

The Copperas Cove Fire Department is organized into two main divisions, led by the Fire Chief and a Deputy Fire Chief. The first is the Operations Division, and the second is the Support Services Division, which includes training, fire prevention, fire investigation, code enforcement, and emergency management.

### Operations Division

The majority of the personnel in the Copperas Cove Fire Department are assigned to the Operations Division. Of the 46 uniformed personnel in the department, 39 are assigned to the Operations Division.

This division provides emergency medical services as well as fire suppression services to portions of Coryell County and the City of Copperas Cove. Additionally, the department is often called upon to provide mutual aid services to the three surrounding counties. The Operations Division also provides “in-service” inspections to all businesses annually and assist with the installation of smoke detectors and the monthly shot clinics that are conducted at Central Fire Station.

The Operations Division consists of 27 firefighters, 6 lieutenants, 3 captains, and 3 battalion chiefs. Each shift is assigned 9 firefighters, 2 lieutenants, 1 captain and 1 battalion chief.

The Operations Division operates on a 24 hours on and 48 hours off scheduling. The division is divided into three shifts that provide the citizens of Copperas Cove professional fire and EMS protection 24 hours a day, 365 days a year.

The operations division handled 5,431 requests for service in 2006.

### Volunteer Firefighters

In 2006, the department reimplemented volunteer firefighters to help supplement operations personnel. These are unpaid personnel who must meet minimum training standards set forth by the department. Volunteer firefighters work shift along-side paid personnel, responding to the same calls and assisting with daily duties.



# Department Organization

## Fire Department Administration (8-hour staff)

Fire Department Administration provides a multitude of services to the department and to the community, and is responsible for functions of administration, fire prevention, fire inspections, code enforcement, and emergency management. Administration is staffed with 2 captains, 1 lieutenant, 3 firefighters, 1 emergency management coordinator, and 2 administrative assistants.

## Training Division

The Training Division is staffed with 1 captain and 1 firefighter. The division provides oversight and management of all issued equipment and uniforms. Additionally, the division is responsible for the city's two way radio and telephone systems for city offices. Training responsibilities include fire and EMS continuing education training, initial certification courses, professional development assistance, Fire and EMS re-certification oversight, and compilation of Fire and EMS training records. All new employee in-processing, oversight for promotional examinations, annual equipment testing and maintenance, are also duties placed on the Training Division, under the watchful eye of the Training Captain.

## Fire Prevention Division

This division is staffed by the Fire Marshal and 1 Lieutenant Inspector. The fire prevention division is responsible for providing pro-active public education programs, fire/arson investigations, fire inspections, and plans and plat review. Public safety programs that are administered by this division include the free smoke detector program, Miss Flame program, and fire prevention poster contest. The division is also responsible for all state fire incident reporting, department statistics, and reports and records.

The Miss Flame Program is held annually during the month of October where local junior high school students compete for the Junior Miss Flame title. These young ladies receive prizes donated by local businesses and a scholarship donated by the Copperas Cove Fire Department. A panel of judges selects the winner.

The Fire Prevention Poster Contest is held in conjunction with Fire Prevention Week. Open to school children at all schools, public and private. Students draw posters depicting areas of fire prevention and safety; division winners compete in state and district competition.

National statistics indicate that “no working detector” is found in one-third of all residential fires. The smoke detector program was implemented to assist citizens in need with help obtaining a smoke detector. The department provides and installs these smoke detectors and batteries to the citizens of Copperas Cove, free of charge.

The Copperas Cove Fire Department Clown Troupe is a voluntary assignment that is comprised of shift firefighters and administrative staff. The purpose of the Clown Troupe is to deliver fire and accident prevention programs to people of all ages through an entertaining format.

### **Code/Health Enforcement Department**

The Code/Health Enforcement Department is a stand-alone department under the supervision of the Deputy Chief. This section consists of 1 part-time clerk and 3 Code/Health Inspectors assigned to Central Fire Station. Services provided by the department are a very important component of maintaining and enhancing the quality of life in Copperas Cove.

The objective of the Code/Health Enforcement Department is to provide quality services to the public by coordinated surveillance, consultation, complaint handling and enforcement to maintain and improve environmental health, public safety and welfare of the citizens. Code Enforcement Officers are responsible for conducting inspections and permitting on all establishments that serves food/drink to the public, as well as abatement of blight and nuisance complaints.

Code Enforcement Officers also provide monthly State recognized Food Handler courses at the Central Fire Station. These classes are required by anyone that works at a Food Service Establishment.

### **Emergency Management Division**

In the 2006-2007 budget process, the City approved a full time Emergency Management Coordinator position.

The Emergency Management Division is supervised by the Deputy Fire Chief and is charged with the overall mission of protecting Copperas Cove’s citizens and their property from the effects of natural, manmade, and technological disasters. To fulfill this mission, the office recognizes and utilizes the four phases of emergency management: Preparedness (planning, training, and exercising on how to respond to an emergency); Response (coordinating activities and resources as the emergency is evolving); Recovery (assisting the local jurisdiction to return to a normal lifestyle); and Mitigation (ways to reduce or eliminate loss if the same event occurs again).

Recent Department of Homeland Security mandates to municipalities include “radio interoperability” and the National Incident Management System (NIMS). During 2005, the State of Texas adopted the Texas Radio Communications Interoperability Plan from the Department of Homeland Security. This plan requires all emergency service providers, including law enforcement, fire and EMS services, to achieve standardized “levels” of effectiveness, based upon regional operating capacity.

According to definitions within the Texas Radio Communications Interoperability Plan, The City of Copperas Cove, Ft. Hood, Bell County and all of their users currently have exceeded requirements by achieving Level 5 Interoperability. Coryell County and Lampasas County are currently at Level 3, which is due to equipment restrictions with the VHF systems that they currently use, and NOT as a result of the 800 Mhz. radio equipment utilized by Bell County, Ft. Hood and Copperas Cove. With the construction of the new radio tower and installation of a microwave link to Ft. Hood and Bell County, we expect our interoperability level to increase to 6 in 2007.

Another major development of 2006 was a Presidential Directive requiring all “first responders” and all persons involved with Emergency Management functions to receive training in the National Incident Management System (NIMS). All police and fire personnel completed the IS-100, IS-200, and IS-700 training, while city department heads and elected officials involved with an Emergency Operating Center (EOC) received the IS-100 and/or IS-700 class. With this, the City of Copperas Cove is compliant with all NIMS requirements.

## *Community Services and Programs*

### **CERT** (Community Emergency Response Team)

CERT (Community Emergency Response Team) was organized in the 1980's by the Los Angeles City Fire Department. The curriculum was established to train citizens to be able to take care of themselves, their families and neighbors in the event of a disaster as emergency services may be delayed up to 72 hours due to demands placed on the system during a major disaster. This program was adopted by FEMA (Federal Emergency Management Agency) and has been used in United States and internationally.

During 2006, 18 citizens of Copperas Cove attended the Community Emergency Response Team training, bringing the total trained to 83. While participating, the citizens are taught basic disaster preparedness, disaster fire suppression, disaster medical operations, light search and rescue, team organization/disaster psychology, and terrorism. During the final week of the course, the students are given the chance to use what they have learned in a disaster simulation. This class is open to the Citizens of Copperas Cove and the immediate surrounding area.

## Citizens Fire academy

The Citizens Fire Academy is a public education tool used to educate citizens of Copperas Cove of services that the Copperas Cove Fire Department provides; to increase fire and life safety awareness as well as to promote a positive image of the department to the community.

The Academy is eight weeks long consisting of classroom and hands-on participation with rescue tools, hose lines, and fire extinguishers. Participants “ride-out” with firefighters to experience first-hand what being a firefighter is like. The highlight of the academy is a Saturday “play day” where recruits experience actual firefighting of a car fire and use rescue tools to cut doors and roofs off of cars.

## Shots through the Firehouse

The Copperas Cove Fire Department operates a “Shots through the Firehouse” program that began in 2000. The Copperas Cove Fire department was the first department in the State of Texas to have children’s immunizations available on a regular basis and free to everyone, regardless of circumstances.

Immunizations are provided on the first Saturday of every month and a huge event is held in August, in preparation for school. This is an all day event in which food, clowns, rock climbing wall and many fun and entertaining activities are provided. During the 2006 year, 1,156 immunizations were provided, and since its inception, 6,769 immunizations have been given, all free of charge.

## MIMES (Mentoring Industrious Minds and Educating Students)

On June 6 2006 the Copperas Cove Fire Department hosted its first annual M.I.M.E.S. camp, (Mentoring Industrious Minds and Educating Students) which targets 7<sup>th</sup> grade students. The camp consists of students from Copperas Cove Junior High and students from S.C. Lee Junior High Schools, selected by CCISD teachers.

The kids spend five days learning many aspects of the fire service beginning with Emergency Medical Services. The students learned about basic first aid and CPR, city government, fire science; math and many other subjects.

Students participate in hands-on demonstrations, experiencing what it is really like to be a firefighter. The week ends with history and traditions of the fire service and an exercise where the kids get to wear protective gear and search a smoke filled room. It is a very educational and exciting week for both the students and the firefighters that participate.

## CENTRAL FIRE STATION

Central Fire Station is located at 415 South Main Street. The City Council approved the construction bid of \$83,775.46 on August 6, 1974. The station was completed and personnel started moving into the station in February of 1975. The station was remodeled in 1999 at a cost of \$750,000. Central Fire Station houses Engine 1, Ladder 1, Booster 1, Medic 1 and Medic 11.

## STATION TWO

Fire Station #2 is located at 1208 West Avenue B. It was constructed in 1977 after the City received a block grant to fund the station and a fire engine. The cost to build the station was \$110,000. Station #2 houses Engine 2, Engine 22, Medic 2 and Medic 22.



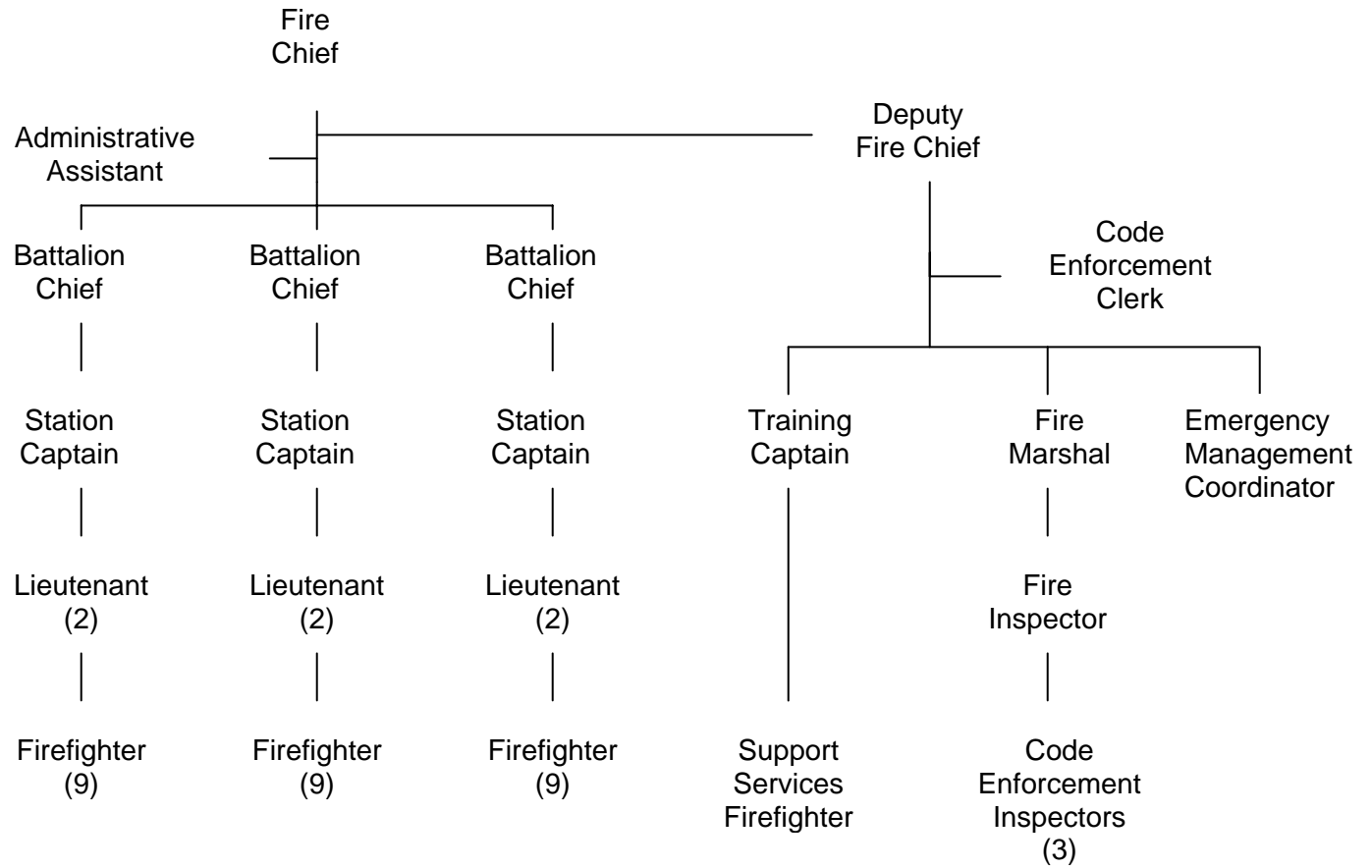
## STATION THREE

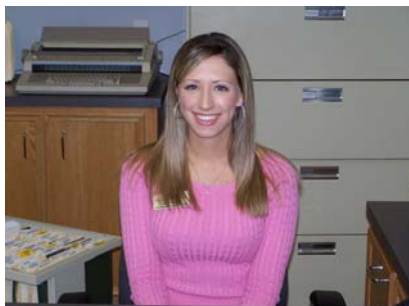
