Authority for this agency to access an individual's criminal history data may be found in Texas Government Code 411; Subchapter F.

RELEASE OF LIABILITY & INDEMNIFICATION FOR VOLUNTEER WORKERS

I hereby release and agree to hold the City harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the City, or that may otherwise arise in any way in connection with any services provided to the City. I understand that this release discharges the City from any liability or claim that I, my heirs, or any personal representatives may have against the City with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services provided to the City.
