Copperas Cove, Texas – The City of Copperas Cove is accepting applications to fill youth positions on the Youth Advisory Council. The purpose of the City Council Appointed Advisory Body is to define specific ways to address youth community issues and the development of activities and programs designed and promoted through the City and the Copperas Cove Independent School District. The Council will also encourage and promote the education of youth regarding City government and importance of youth input, participation and responsibility.

The advisory body consists of thirty youth members and one adult liaison, appointed to two year terms each, and meets monthly on the first Monday. Eligible youth participants must be a student, between grades 8-12, and in good standing.

The position vacancy will be advertised through November 20, 2015. History (CCH) check will be performed by accessing the Texas Department of Public Safety Secure Website and will be based on name and DOB identifiers I supply. (This is not a consent form.) Authority for this agency to access an individual's criminal history data may be found in Texas Government Code 411; Subchapter F.

Name-based information is not an exact search and only fingerprint record searches represent true identification to criminal history, therefore the organization conducting the criminal history check is not allowed to discuss with me any criminal history record information obtained using this method. The agency **may** request that I have a fingerprint search performed to clear any misidentification based on the result of the name and DOB search. Once this process is completed the information on my fingerprint criminal history record may be discussed with me.

In order to complete the process I must make an appointment with the Fingerprint Applicant Services of Texas (FAST) as instructed online at [www.txdps.state.tx.us /Crime Records/Review of Personal Criminal History](http://www.txdps.state.tx.us/Crime%20Records/Review%20of%20Personal%20Criminal%20History) or by calling the DPS Program Vendor at 1-888-467-2080, submit a full and complete set of fingerprints, request a copy be sent to the agency listed below, and pay a fee of \$24.95 to the fingerprinting services company.
