Shooting Incident

COPPERAS COVE, TEXAS – On June 21, 2016 at approximately 1:18 A.M. hours, Copperas Cove Police were notified of a 20 year old male gunshot victim that was being treated at Metroplex Hospital. During the investigation Detectives discovered the crime scene in the 1000 block of Industrial Avenue.

We are in the early stages of the investigation and additional information will be released as it becomes available.

Update

On June 21, 2016 at approximately 1:18 A.M. hours, Copperas Cove Police were notified of a 20 year old male gunshot victim who was identified as Damontay Devin Holmes that was being treated at Metroplex Hospital. During the investigation Detectives discovered the crime scene at 1005 of Industrial Avenue. Several shell casings were located in front of the apartment and it was evident that rounds had been fired into and possibly from the residence.

Police personnel attempted to make contact with the occupants of 1005 Industrial Avenue, but were unsuccessful in doing so. Not knowing if there were any injured parties, or possible suspects within the residence, CCPD SWAT was requested. The residence was cleared and no one was located within. The scene was turned over to Detectives for processing.

During the initial investigation, Detectives were able to locate and interview the residents of 1005 Industrial Ave. They advised that a home invasion had occurred and that unknown subjects had forced their way into the residence. One of the residents was able to retrieve a firearm and an exchange of gunfire took place. After the exchange of gunfire, the suspects fled. None of the occupants of the residence were injured.

Detectives later interviewed the subjects who drove Damontay to the hospital. During the course of the investigation, Detectives were able to obtain the identity of the suspects, as well as confirm that the intent of the suspects was to commit a robbery. Arrest warrants were issued on June 22, 2016 by Judge John Guinn for Aggravated Robbery for Xavier Clifford Arnold, Marcus Anthony Herrera, Warren Darnell Jackson, and Marcus Dwayne Robinson.
