COVID-19, Coryell County Mobile Testing Results

Thursday May 21, 2020

Copperas Cove, Texas – On May 14, 2020 mobile testing was conducted in Coryell County. Testing was conducted at two sites, Gatesville Civic Center and Copperas Cove Fire Station 2. Additional data has been received concerning the testing at the two sites:

	Positive Cases	Negative Cases	Pending results
Gatesville	0	28	0
Copperas Cove	1	116	3

The single positive case is a resident of Coryell County (Copperas Cove).

During both test sessions fewer persons made appointments to undergo testing compared to the number of testing kits that were available.

All citizens are reminded to continue engaging in social distancing, proper hand hygiene, staying home when you do not feel well and compliance with suggestions for utilizing face masks.

Friday May 15, 2020

Copperas Cove, Texas – On May 4, 2020 mobile testing was conducted in Coryell County. Testing was conducted at two sites, Gatesville Civic Center and Copperas Cove Fire Station 2. Additional data has been received concerning the testing at the two sites:

	Positive Cases	Negative Cases	Pending results
Gatesville	0	58	0
Copperas Cove	4	102	1

One of the four positive cases is a resident of Coryell County (Copperas Cove) while the other three live elsewhere. Cases are reported to County Officials of the County where the person resides, not where they were tested.

On Thursday May 14, 2020 another mobile testing session was held in Coryell County again in Gatesville and Copperas Cove. End of day counts of tests administered that were provided by the testing teams were Gatesville 24 and Copperas Cove 117.

Once more information is made available from the test results it will be disseminated.
