Main Street Mill and Overlay Project (Update)

Copperas Cove, Texas – A City of Copperas Cove Mill and Overlay Project will begin on **Monday, November 30, 2020** and work is expected to last through **Thursday, December 3, 2020**, barring inclement weather. During this time Texas Materials Group, Inc. will be resurfacing Main Street from Avenue F to the North City limits, milling 1" of old asphalt and overlaying with a new layer of asphalt. The bid contract was awarded by City Council on September 1, 2020 in the amount of \$181,759.11. These improvements are part of the City's Street Maintenance Program and are being funded exclusively by the 1/8th Cent Sales Tax allocation, as approved by the voters of the City of Copperas Cove during a Special Election held in November of 2016.

The attached amended notice will be distributed to all affected residents and business owners, requesting that all vehicles, trailers and similar obstructions are removed from the street daily during this scheduled project period from 6am to 7pm. Solid Waste collections will continue as scheduled, however residents and business owners along Main Street are asked to keep all items out of the street and on top of the curb until work is completed.

All motorists are encouraged to follow posted road construction signs for the safety of themselves and work crews.

NOTICE (Amended 11-10-2020)

During the period of Monday, November 30, 2020 through Thursday, December 3, 2020, Texas Materials Group, Inc. will be resurfacing the City street in your area. Texas Materials Group, Inc. will be removing 1" of asphalt and replacing it with a fresh layer of 1" of asphalt.

The areas affected are as follows:

November 30, 2020:

- South Main Street from East Avenue F to East Avenue D

December 1-3, 2020:

- North Main Street from East Avenue D to the Railroad Tracks
- North Main Street from the Railroad Tracks to the North City Limits

In order to complete the work, the City is requesting the following:

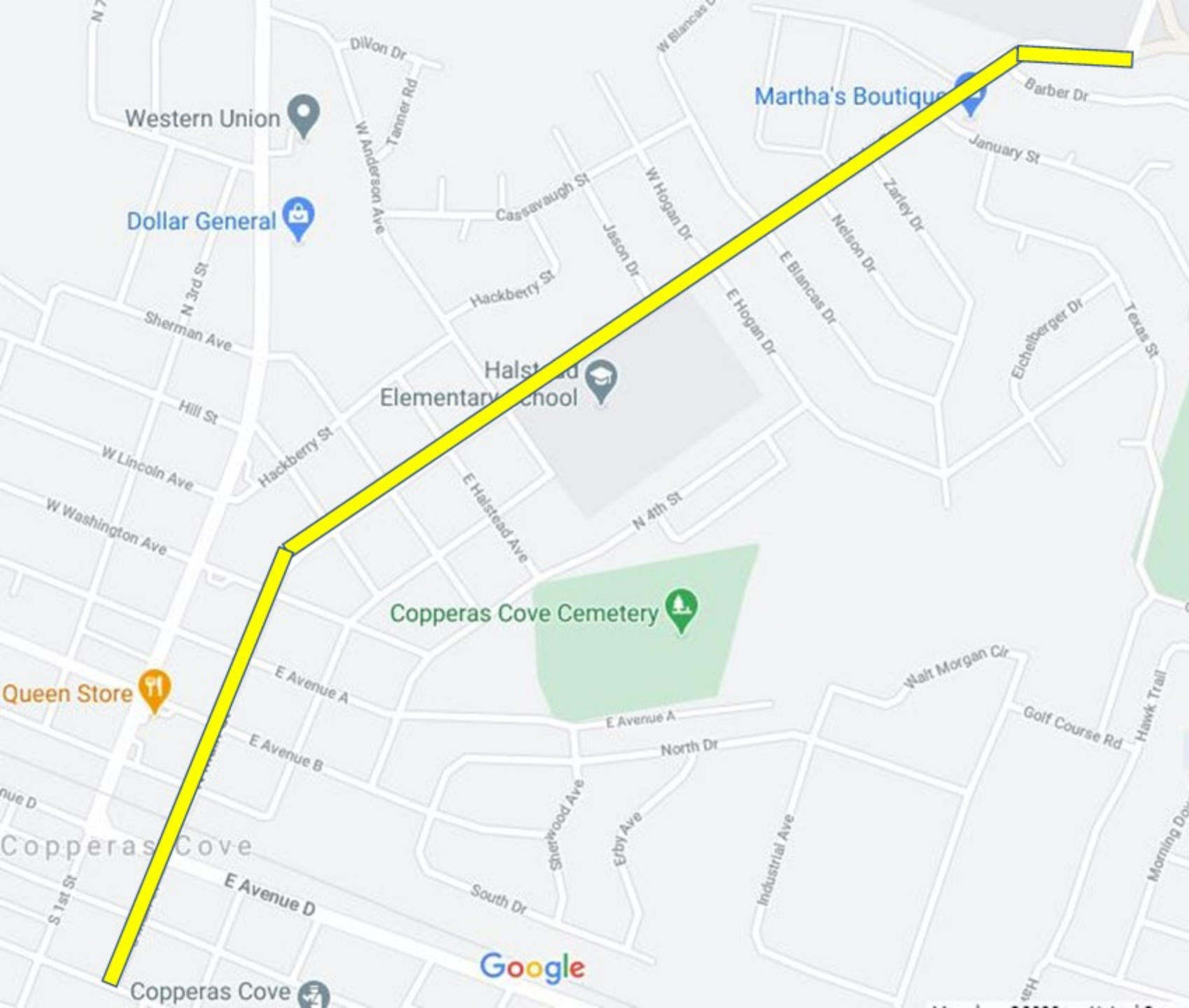
All vehicles, trailers and other obstructions are to be off the street starting Monday, November 30, 2020 through Thursday, December 3, 2020, from 6:00 a.m. to 7:00 p.m.

Garbage and recycle collection will run as normal. Place trash and recycle bins on top of the curb and not in the gutter until the work is complete.

Residents and Businesses who will be unavailable or out of town during this time period are asked to remove any vehicles, trailers or other obstructions off the street prior to leaving.
